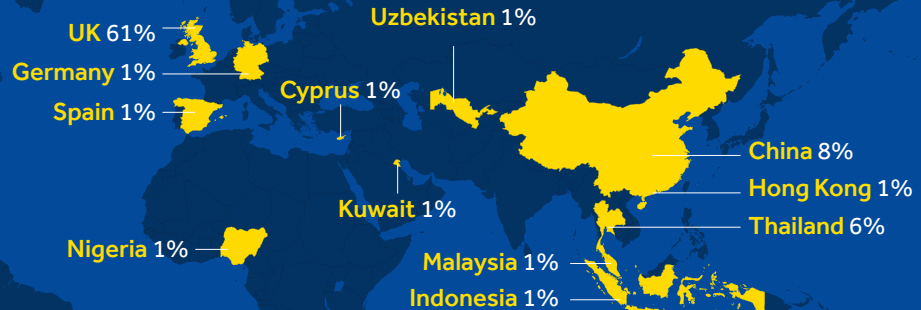

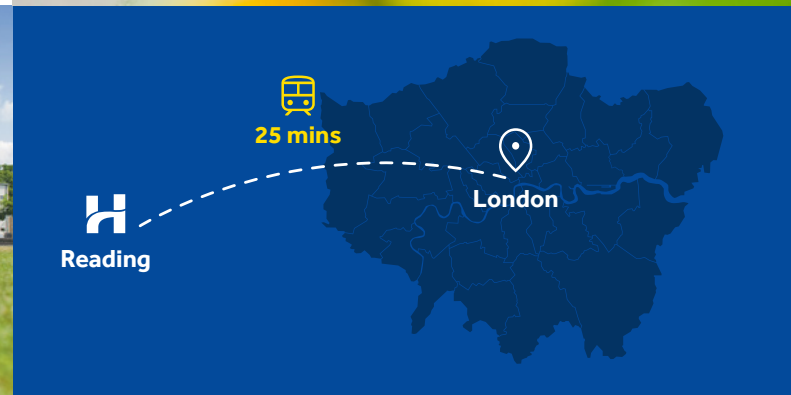

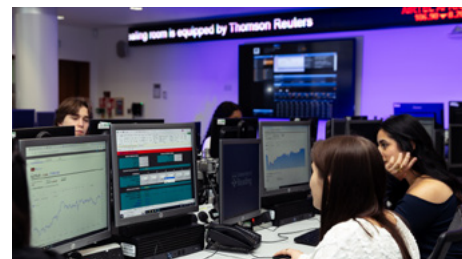
The University Library
